Dear Villa Nova Neighbor:

In mid-November, the Baltimore County Council proposed their redistricting map. Their map is bad news for Villa Nova. The Baltimore County Council has denied our request to unite the Villa Nova Community into District 2, Pikesville. They did this even though the County's own Bipartisan Redistricting Commission proposed that the community be united in District 2, Pikeville, rather than be divided between Randallstown District 4. To add insult to injury, the Baltimore County Council proposed to combine Towson together over 3 districts, even though this was not recommended by the County's Bipartisan Redistricting Commission.

- This division creates problems with getting county services for Villa Nova
- This division creates problems with getting attention from the police department in Villa Nova
- This map will not allow Villa Nova residents to elect school board members for our district

It is important to note that the Baltimore County Council ignored the County's Redistricting Commission proposal and included Towson in one district, but did not do the same for Villa Nova, Milford or Lochearn. WHY????? WHAT MAKES US DIFFERENT????

We are requesting your support in our efforts to strengthen our Pikesville communities as we work hard to preserve, maintain, and conserve our suburban lifestyle. In addition, with these communities being moved to District 2 as we have requested, we will gain, for the first time, the ability to vote for the school board member that aligns with the schools our children attend. Our children, appropriately attend Pikesville schools, yet parents have to vote in District 4. This decision is unfair and we need this injustice to end. This realignment is long overdue and should no longer be denied to us.
